### CIRCULAR Nº YAT 008

### **GUIDELINES FOR THE STATIC YACHT EVENTS\***

TO: YACHTS' OWNERS AND MASTERS, SURVEYORS TO

FLAG STATE, ADMINISTRATION AND RECOGNIZED

**ORGANIZATIONS** 

**APPLICABLE TO:** All yachts

**EFFECTIVE AS FROM** 25 April 2024

- A The guidelines for the Static Yacht Events are issued by the St Vincent and the Grenadines Maritime Administration to ensure a practical safe and homogeneous approach to this ever-growing market.
- B These guidelines are applicable to registered yachts (Commercial & Pleasure) flying the St Vincent and the Grenadines Flag.
- C The Master/Owner/Managets is/are fully responsible at all times for all the persons onboard the yacht.
- D) In the event that a **Commercial Yacht** will remain moored; berthed or anchored at sea, the yacht may be allowed to carry more than 12 passengers in line with the requirements and the process set out in these quidelines.
- E) In the event that a **Pleasure Yacht** will remain moored; berthed or anchored at sea, the yacht may be allowed to carry guests exceeding the total number of persons permitted during normal operations, in line with the requirements and the process set out in these guidelines.
- F) For a **Commercial Yacht** and for a **Pleasure Yacht** to be able to partecipate to a Static Yacht Event, the yacht shall be issued with a letter TO WHOM IT MAY CONCERN by this Administration. The application for the issuance of the TO WHOM IT MAY CONCERN, shall be addressed to this Maritime Administration and shall include:
  - a) details of the yacht including name and official number.
  - b) The maximum number of persons to be carried out on board during the Static Yacht Event.
  - c) The total number of crew and other staff (non-passengers/non-guests) to be carried on board during the Static Yacht Event.
  - d) A risk assessment, carried out by a Classification Society/Recognized Organization (recognized by this Maritime Administration) or by a surveyor appointed by this Maritime Administration. The risk assessment shall identify all risk associated with the yacht participating in the Static Yacht Event, when berthed and/or anchored at sea and shall include recommendations about any necessary mitigating to be taken/undertaken.
  - e) confirmation from a Recognized Organization or from a surveyor appointed by this Maritime Administration that the yacht's approved Stability Booklet or Stability Calculation (yacht less that 24 m in lenght as defined by the Safety Codes for pleasure and commercial yachts) includes a loading

condition taking into consideration the maximum number of persons carried onboard and any additional ancillary equipment utilized during the Static Yacht Event. This loading condition shall also include (for yacht not permanently moored at pier) the possible shifting of all persons to one side of the highest deck of the yacht at the same time (crowding).

- e) the availability of adequate insurance coverage.
- G) Confirmation by the Master/owners/Managers that the yacht shall abide by the following condition and requirements whenever a Static Yacht Event is planned:
  - i) the necessary lifesaving appliances, namely lifejackets and liferafts, are provided for the total number of persons on board during the Static Yacht Eventvent when the yacht is anchored at sea
  - ii) At least, two means of escape shall be available from the yacht during a Static Yacht Event held permanently moored at the pier.
  - iii) The crew shall be adequately trained and an evacuation drill shall be carried out prior to the commencement of the Static Yacht Event.
  - iv) The port Authority shall be notified about the Static Yacht Event, beforehand.
  - v) The yacht shall remain moored throughout the event.
  - vi) Static Yacht Event at anchorage shall only be undertaken in good weather conditions and the yacht shall remain moored within 1 nautical mile from the coast/safe haven.
  - vii) During Static Yacht Event at anchorage, any boats remain for the full duration of the Static Yacht Event.
  - Subsequent to the satisfactory review of the Static Yacht Event application, the yacht will be issued with a TO WHOM IT MAY CONCERN, authorizing the Static Yacht Event to be held on board. The TO WHOM IT MAY CONCERN will be valid for the specific Static Yacht Event and subject to valid Certificate of Registry and valid applicable Statutory documents/certificates.
- J) Whenever a Static Yacht Event is planned the Master/owner/Managers shall inform the local port authority and send a notification to this Maritime Administration.

\*Static Yacht Event: an event where the yacht is moored for the duration of the event and utilised as an entertainment facility
